ARTICLE 1: LEGAL

www.attrap-reves.com is governed by the terms and conditions of sale and supply of Bruno Giovansili, registered with the Marseille Trade and Companies Registry under number 520 456 096, with registered office at Chemin de la Ribassière, 13190 Allauch. Attrap'Rêves offers bubbles intended for use as leisure accommodation onsite.

ARTICLE 2: APPLICABILITY - OPPOSABILITY

These General Conditions of Sale govern any purchase that you make via the website www.attrap-reves.com, as well as bookings, cancellations and liability, to the exclusion of any other terms and conditions or contractual documents. By placing an order via www.attrap-reves.com, the purchaser is deemed to have consulted and validated these General Conditions of Sale and to have accepted them in full and without reservation.

<u>www.attrap-reves.com</u> reserves the right to modify or amend these General Conditions of Sale at any time. The version of the General Conditions of Sale that applies to an order is that which is in force on <u>www.attrap-reves.com</u> at the time the order is confirmed by the customer (validation of online payment).

ARTICLE 3: BOOKING AND PURCHASING GIFT VOUCHER

BOOKING:

You can book directly with us via the website www.attrap-reves.com. We have a real-time booking system. That way, once you have validated your booking, you will receive confirmation from us by email. The booking is immediately recorded by us. We ask you to print out the booking confirmation that you'll receive by email.

For the booking, you will be asked to pay 30% of the amount via our secure online payment system or bank transfer.

The balance must be payable 10 days prior to your arrival at the latest. You will receive several email reminder regarding this. If not, the booking will be automatically cancelled and the deposit definitely lost.

If you book within 10 days of your arrival date, you will be asked to pay the total amount for your overnight stay via our secure online payment system.

GIFT VOUCHER PURCHASES:

Once the online payment has been made, the purchaser can personalise and print out the Attrap'Rêves gift voucher that he/she wishes to give. The gift voucher has an activation code that allows the beneficiary/beneficiaries to book directly online. We strongly recommend booking ahead since we are often booked up 3 months in advance.

The gift voucher is valid for one year from the date of purchase for use anywhere on the network.

ARTICLE 4: PRICES AND PAYMENT PRICES:

Prices per night are shown in Euros and including VAT.

An additional tax (local accommodation) will be paid (except minors) on your arrival day for the following locations: Allauch, La Bouilladisse Attrap'Rêves reserves the right to modify the rates at any time. The rate applicable to your order is the rate that you paid online and that is confirmed in the summary of the order that you receive by email.

PAYMENT:

The products are paid for in Euros at the time of the order. They are billed to you on the basis of the price and VAT rate in force at the time when you placed the electronic order and are given in your confirmation email. The services ordered may be paid for using any credit card carrying the CB sign: Visa, Eurocard and/or MasterCard. When placing your order, you must enter both your credit card number and the expiry date. The card must be valid on the departure date of the customer who booked the stay. Our booking system is secure and your credit card number, as well as any personal data that you give us, are secure.

A 30% deposit must be paid when the order is placed. Attrap'Rêves reserves the right to suspend/cancel your order should payment authorisation be refused by the accredited official bodies or in the event of non-payment. The balance is due 10 days prior to your arrival. You will receive an email reminder to that effect.

ARTICLE 5: TAKING POSSESSION OF THE ACCOMODATION

You will take possession of the accommodation on the date chosen at the time of the order. Check-in and check-out times may vary from site to site.

However, Attrap'Rêves reserves the right, for reasons of safety, in the event of bad weather or violent winds (meteorological office orange alert), to postpone your overnight stay.

The booking shall remain valid for the remainder of its period of validity. The customer will, therefore, be asked to choose a new date. We will not, under any circumstances, be liable for any travel or accommodation costs incurred by the customer.

ARTICLE 6: BOOKING CANCELLATION CONDITIONS

If the customer took out cancellation insurance at the time of the online purchase, he/she will be reimbursed his/her payment subject to the conditions of our partner: Grichten Assistance which our contract number is 78 891 885.

If the customer did not take out any cancellation insurance, the entire cost of the stay will be billed in the following cases:

- The booking is cancelled within 14 days of the arrival date;
- The booking is cancelled after arrival;
- The stay is shorter than booked; or
- No-show.

If the customer did the 30% deposit and cancelled his booking within 14 days of the arrival date, he will lose the whole deposit. Otherwise, the balance will be also billed.

ARTICLE 7: GIFT VOUCHER CANCELLATION CONDITIONS

Gift vouchers may not be changed or reimbursed once the stay date has been chosen or not.

Attrap'Rêves reserves the right to postpone your overnight stay in the event of bad weather or violent winds (meteorological office orange alert).

If the customer (the person making the purchase and who is giving the gift voucher) took out cancellation insurance at the time of the online purchase, he/she will be reimbursed his/her payment subject to the conditions of our partner: Grichten which our contract number is 78 891 885.

If the customer (who is given the gift voucher) has not taken out any cancellation insurance, the entire cost of the stay will be lost in the following cases:

- The booking is cancelled within 14 days of the arrival date;
- The booking is cancelled after arrival;
- The stay is for few days than booked; or
- No-show.

ARTICLE 8: ACCOMODATIONS TENANTS' OBLIGATIONS

- Take all due care when using the rented accommodation, in accordance with Article 1728 of the French Civil Code, and not commit any damage.

 Smoking is strictly prohibited inside the bubble.
- Vacate the accommodation on the last day of the rental period considerating the check-out schedule and leaving it in the state in which it was received.
- For safety reasons, children under 6 years old (for bubbles) are strictly forbidden. If the customer doesn't respect this rule, he'll have to leave the hotel and the night will be definitely lost. We'll not refund the money back.

ARTICLE 9: OBLIGATIONS OF ATTRAP'RÊVES

- Provide the person renting the accommodation with an object in a good state of repair (Article 1720 of the French Civil Code);
- Guarantee the person renting the accommodation quiet enjoyment thereof, (free from) any defects that might prevent such (Article 1721 of the French Civil Code
